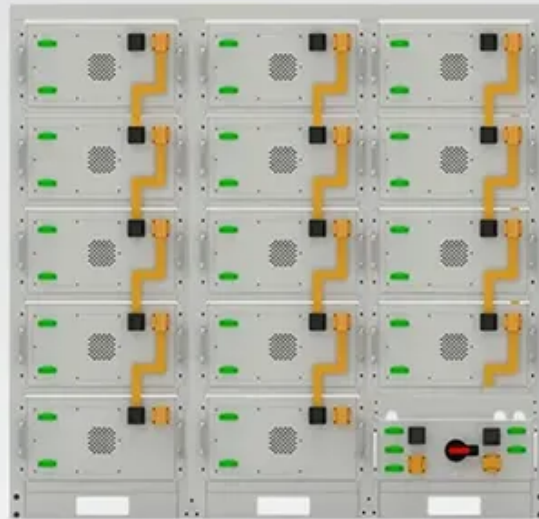

These ports handle a diverse range of cargo types—bulk (e.g., coal, grain), containerized goods (e.g., electronics, textiles), and general cargo (e.g., vehicles)—and operate under varied management models, from fully public or private to hybrid public-private partnerships. The International Maritime Organisation (IMO) made a bold move by mandating, as of January 1st, 2024, that all commercial ports implement digital platforms to exchange information and streamline port call procedures. This requirement

In the same vein, there has been a relatively weak port traffic flows in Africa compared to other developing regions which contributes to high container costs, lengthy trade procedure times, poor port quality infrastructure and low logistic performance.

How much does container shipping cost in Africa excluding North Africa?

The average container shipping costs to, and from Africa excluding North Africa, is relatively high compared to other regions of the world. For example, average costs to export and import a container (TEU) in Africa excluding North Africa were 2201 US\$ and 2931 US\$ respectively in 2014.

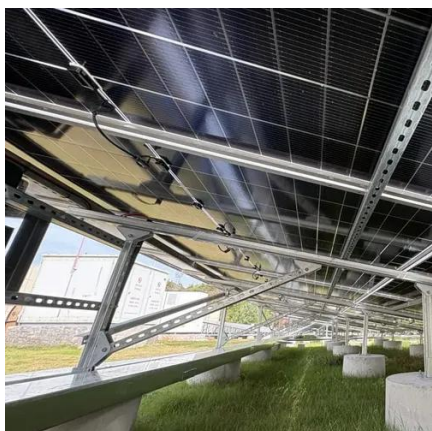

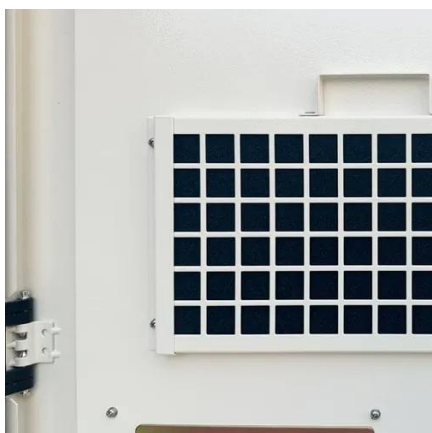
